## 3. DESCRIPTION OF KNOWLEDGE AND SKILLS

### The holder

- has a broad specified knowledge of soil and surface materials in landscape gardening, both organic or non organic substances
- knows how to handle the most common species of garden plants suitable for the Icelandic environment, Knows the most common blights and the methods used to work against them
- creates and follows maintenance plans for green areas
- project manages new projects in gardens, open areas and maintenance of cultivated areas
- landscapes as needed and ensures appropriate ways of water drainage
- is able to use the appropriate machinery
- advises on the choice and handling of the most common species of plants, the most common pests affecting gardening and methods used to fight against them
- is able to work independently and supervise others
- is able to make business plans and tender for projects. Has the skills to run a landscape gardening business
- is able to communicate both orally and in writing about the current situation and the future of landscape gardening from a professional view point
- observes safety in the workplace, by using personal protection, etc.

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

Landscape gardeners plan, cultivate and keep gardens and other outdoor areas containing lawns, flowerbeds, walking paths, stone slab paths, stone walls, trees and other vegetation, based on blueprints or drawings by a landscape architect. Authorised to work as landscape gardeners are those who have earned a journeyman's certificate in landscape gardening, issued by the Minister of Industry and Innovation.
